

ITINERARY

Day 1: Home City ~ Lancaster County ~ Kitchen Kettle Village ~ Dutch Apple Dinner Theater:

Depart aboard a deluxe highway coach for Lancaster County, PA. Rest and meal stops will be made periodically. Later this afternoon we arrive at Kitchen Kettle Village. This quaint complex features over 30 country shops filled with local crafts, fine furniture making, leather tooling, folk carvings, exquisite quilting and plenty of good foods. Enjoy a delightful evening of good food and entertainment at the Dutch Apple Dinner Theater. After a delicious dinner we enjoy the musical Beauty and the Beast. Be our guest in the enchanted world of *Disney's Beauty and the Beast* with Belle, a young woman in a provincial town, and the Beast, who is really a young prince trapped under the spell of an enchantress. If the Beast can learn to love and be loved, the curse will be broken, and he will be transformed into his former self...but time is running out! Enjoy the classic songs such as "Belle", "Be Our Guest", "Gaston", and "Beauty and the Beast". Later this evening we arrive to our hotel for a delightful two-night stay.

Day 2: Bird-in-Hand Farmers Market ~ Sight & Sound Millennium Theater ~ Mount Hope Estate & Winery – Enjoy breakfast at the hotel. Depart for Bird-in-Hand Farmers Market, a favorite destination for locals, as well as out-of-town visitors. It features tons of delicious offerings, including a wide variety of baked goods, chocolates and candies, bulk foods, spices, coffee and loose-leaf tea, locally made chips, fresh-squeezed lemonade, apple cider and rows of homemade canned goods. Later today we arrive to the

Day 3: Historic Lititz ~ Julius Sturgis Pretzel Bakery ~ Wilbur's Chocolate ~ Journey Home:

Enjoy breakfast at the hotel. This morning we travel to the quaint town of Lititz, dedicated in 1756 as a Moravian community. Visit the Julius Sturgis Pretzel Bakery, the first pretzel bakery in the United States and Wilbur's Chocolate, a long-standing establishment in Lancaster County. Enjoy free time for lunch and shopping on own along historic East Main Street. Later today we leave eastern Pennsylvania and begin our journey home. Rest and meal stops will be made periodically.
